If the past semester is any guide, they will pursue work that makes an impact, and form friendships that provide support and levity. Throughout the spring, our teams traveled to Costa Rica and France, New York and Virginia, and many places in between, to meet with colleagues and partners, present reports to states parties, and engage in advocacy with stakeholders. Our clinical projects addressed a wide range of issues, from nuclear weapons and killer robots, to indigenous rights and enforced disappearances, to corporate accountability and reparations. We hosted several major events including a panel on the human rights impact of the recent earthquakes in northwest Syria, a talk with the team who secured a jury verdict in U.S. federal court against a Haitian mayor for torture and extrajudicial killings of political opponents, and a conversation about the Inter-American Commission of Human Rights with its Deputy Executive Secretary.

We're already looking ahead to an exciting fall semester filled with new faces, clinical projects, events, and classes. But first, we wish you a productive and rejuvenating summer!

Clinical Project Highlights



In May, Clinic partner Bloom (France) launched a report on human rights abuses in the tuna industry. The report, Canned Brutality, describes endemic abuses in the tuna supply chain, including forced labor, slavery, and trafficking of workers. The Clinic provided legal advice, research, and drafting support for the report, which analyzes corporate failures and shortcomings in the EU's import control scheme. A clinical team traveled to France over spring break to collaborate directly with Bloom on this project.



Recommending New Guidelines for Reporting on TPNW Victim Assistance, Environmental Remediation

The Clinic published a **new report** in May regarding reporting guidelines for the Treaty on the Prohibition of Nuclear Weapons (TPNW). Reporting on treaty implementation promotes monitoring and accountability,

encourages the exchange of information and expertise, and facilitates assistance between states parties. The team provided a close analysis of precedent under other disarmament treaties and made recommendations for adapting it for reporting on victim assistance, environmental remediation, and international cooperation and assistance under the TPNW. The team's supervisor presented their publication to TPNW states parties, which are considering a new format for reporting in the lead up to their annual meeting in November.

Advancing Legal Frameworks for Enforced Disappearances

A paper co-authored by the Clinic and Jimena Reyes, the Americas Director at the International Federation for Human Rights, was presented at a May symposium on the evidentiary regimes of UN Treaty Bodies held in Ghent, Belgium. The paper describes how obstacles to accountability for enforced disappearances are even more profound in contexts of extreme violence and widespread impunity, and where non-State actors such as drug cartels and organized criminal groups perpetrate the abuse. The article considers how the UN Committee on Enforced Disappearances should determine when a disappearance perpetrated by non-State actors constitutes an enforced disappearance.

Advocating for Remedies to the UN Special Rapporteur on Truth, Justice & Reparations

In March, a clinic team advocating for remedies for lead poisoned Roma communities in Kosovo contributed to the UN Special Rapporteur on Truth, Justice and Reparations' forthcoming thematic report on best practices in financing reparations around the world. The team analyzed lessons from the UN's own failed efforts to adequately finance remedies for UN-caused harms, drawing on the Clinic's work in Haiti and Kosovo stretching back to 2019. The team also co-authored a paper examining the lead poisoning as a case study of environmental racism against Roma people, which was presented at a Critical Romani Studies conference at Central European University in June.



In April, a clinical team advocating for a treaty to regulate international trade in law enforcement equipment responded to a call for inputs from a different UN Special Rapporteur - on torture and other cruel, inhuman and degrading treatment or punishment – to inform her upcoming report on the relationship between law enforcement equipment and torture and other ill-treatment. Drawing on comparative and international trade law research, the Clinic illustrated how a treaty could advance transparency in trade through common standards. The Clinic also collaborated with its partners in the civil society Torture-Free Trade Network to make a joint submission from 57 organizations highlighting the urgent need for a Torture-Free Trade Treaty.

Supporting Indigenous Self-Determination in Mexico

The Clinic initiated a new clinical project this spring supporting the Colectivo Emancipaciones, a group of community lawyers in Mexico who work with indigenous communities in the state of Michoacán. A student team developed legal argumentation to feed into a petition to the Inter-American Commission on Human Rights aimed at upholding indigenous communities' right to self-determination. We were grateful for the assistance of HLS SJD student Angel Cabrera Silva, who is also a member of the Colectivo.



Campaigning to Stop Killer Robots

In February, a clinical team attended a **global meeting** of the Stop Killer Robots campaign in San José, Costa Rica. The Clinic has worked closely with the campaign for many years to advocate for a new treaty that would include prohibitions and regulations on autonomous weapons systems. At a government-hosted meeting, the Clinic presented the findings of a **report** we released last semester on these issues.

On the heels of a landmark jury verdict in Boston against a Haitian mayor sued for torture and extrajudicial killings, the Clinic and Advocates hosted the Haitian human rights defenders and their lawyers who brought the case. The event was a unique opportunity to celebrate a hard-won victory in *Boniface v. Viliena* that followed a 15-year legal battle, and to reflect on the human rights violations and challenges facing the plaintiffs along the way. The event concluded to jubilant news that federal authorities had arrested the mayor, adding another layer of accountability.
